

CLINICAL POLICY ADVISORY GROUP (CPAG)

Brow Lift Policy

Statement

NHS Derby and Derbyshire ICB (NHSDDICB) has deemed that brow lift should not routinely be commissioned, unless criteria A <u>or</u> B is met:

A. There is brow ptosis causing functional visual impairment (impaired within 30 degrees of line of sight)

OR

- B. The brow ptosis is caused by any of the following examples
 - o facial palsy (congenital or acquired paralysis)
 - o acute trauma
 - sequelae of specific medical conditions, e.g. cutis laxa, neurofibromatosis, pseudoxanthoma elasticum

The procedure is not commissioned as a cosmetic intervention (at any age) without accompanying functional impact.

These commissioning intentions will be reviewed periodically. This is to ensure affordability against other services commissioned by the ICB.

1. Background

A brow lift is a surgical procedure that involves the elevation and repositioning of the skin and soft tissue around the upper area of the face. The procedure uses the same surgical principles and techniques as craniofacial surgery, allowing access to the upper face.

Brow lifts are often used to correct brow ptosis (droop). Brow ptosis can occur as part of the natural aging process due to the skin and muscle around the upper face area losing elasticity with age. However, in some people, brow ptosis can be caused as a consequence of:

- facial palsy (congenital or acquired paralysis)
- o acute trauma
- sequelae of specific medical conditions, e.g. cutis laxa, neurofibromatosis, pseudoxanthoma elasticum

This procedure carries the risk of scarring and paraesthesia.

2. Recommendation

Brow lift should not routinely be commissioned, unless criteria A or B is met:

A. There is brow ptosis causing functional visual impairment (impaired within 30 degrees of line of sight)

OR

- B. The brow ptosis is caused by any of the following:
 - facial palsy (congenital or acquired paralysis)
 - o acute trauma
 - sequelae of specific medical conditions, e.g. cutis laxa, neurofibromatosis, pseudoxanthoma elasticum

The procedure is not commissioned as a cosmetic intervention (at any age), without accompanying functional impact.

3. Rationale for Recommendation

- Aging can cause changes to the face and brow that may be considered as being normal
- There are several specific conditions that can cause brow ptosis for which a brow lift may form part of the treatment to restore function.
