

CLINICAL POLICY ADVISORY GROUP (CPAG)

Mastopexy (Breast Uplift) Policy

Statement

Derby and Derbyshire CCG has deemed that mastopexy should not routinely be commissioned unless the procedure is for breast reconstruction as part of the management of breast cancer, where one asymmetry procedure should be done.

These commissioning intentions will be reviewed periodically. This is to ensure affordability against other services commissioned by the CCG.

1. Background

Mastopexy is a surgical procedure that involves the removal of extra loose skin from the breast to help lift and reshape them. The procedure can lead to reduced sensation in the breast and nipple.

2. Recommendation

Mastopexy should not routinely be commissioned unless the procedure is for breast reconstruction as part of the management of breast cancer, where one asymmetry procedure should be done.

3. Rationale for Recommendation

The restriction of activity to just one procedure will improve patient outcomes by limiting post-operative complications to one spell and encourage providers to get surgery right first time.
