#### Advice on dealing with fraudulent prescriptions

Over recent months there has been a small increase in the number of reported fraudulent prescriptions presented at pharmacies. Community pharmacists are asked to treat any handwritten or amended prescriptions with extreme caution and to check with the prescriber if you have any concerns.

How to spot a fraudulent prescription:

- Spelling mistakes, awkward phrasing, such as 'nightly'/ & odd names
- GP signature unusual, suspiciously illegible?
- General manner of the person presenting the prescription
- Often fraudulent prescriptions are presented out of surgery hours late, or at weekends
- Odd quantities or drug combinations e.g. nitrazepam and diazepam
- Think about who would be hand writing this script, and why e.g. a month's supply of tramadol, pregabalin, diazepam, nitrazepam, codeine – unlikely from a home visit?
- Handwritten prescriptions would not normally be written on an FP10SS form (designed for printing) – if this form has been used with a stamp, or handwritten surgery address, it is likely to be fraudulent

If you believe that a prescription is fraudulent, contact the police on 101 and the CDAO. Any pharmacy detecting and retaining a fraudulent prescription are eligible for a reward payment, details are in the Drug Tariff.

#### **CDs and Fitness to drive**

Learning from a recent CD incident highlighted uncertainty from the prescriber involved as to when the DVLA should be contacted with regards to fitness to drive.

For guidance on this issue the DVLA have a publication which is intended to assist doctors and other healthcare professionals. It summarises the national medical guidelines on fitness to drive and should help prescribers identify when they are required to notify DVLA when the individual concerned, cannot or will not notify the DVLA themselves:

## **Safe Disposal of Empty Methadone Bottles**

The Medicines, Ethics and Practice (MEP) guidance advises that once a methadone bottle is emptied as far as possible, bottles can be rinsed out and the liquid added to a denaturing kit and treated as pharmaceutical waste. You can use cat litter to dispose of the rinsings so you will not have to use denaturing kits for this rinsing.

The empty rinsed bottles can then be disposed of via your general waste or recycling. Disposal of irretrievable amounts of controlled drugs does not need to be recorded.

#### Common Issues Identified at CD Destruction Visits

Running Balance - The running balance of a controlled drug must include any out of date stock, until the denaturing of the item is witnessed by an authorised witness. CD running balances should be calculated and recorded after each transaction and regular stock balance checks should be completed as per your SOPs. Best practice is to complete stock checks weekly as it helps to identify any discrepancies or errors quickly and allow timely investigation of the discrepancy.

New CD Registers - Take care transferring quantities from old CD registers to new to ensure your balance figures are accurate.

Patient Returns - Patients Schedule 2 CD returns should be recorded in the bound patients CD returns book as soon as practicable i.e. on the day they are received and denatured in a timely manner. A second member of staff should act as a witness, recording the destruction in the patients CD returns book.

CD Register Corrections/ Amendments - Ensure any corrections/amendments in the CD register are not crossed through or rubbed out. They should have an asterisk (\*) next to the entry and details of the amendment entered as a footnote next to another asterisk (\*) at the bottom of the page. This entry must be signed and dated. Remember to always use an indelible pen, do not use pencil or corrective fluid.

#### **Effects of NPS**

You can report the harmful effects of NPS on the Public Health England website. Report Illicit Drug Reaction (RIDR) is intended to better monitor the negative effects

of NPS and share best treatment including A&E, sexual health clinics, mental health services, prison health services, drug

treatment services and GP practice across a variety of settings surgeries. Data from the tool will be analysed by experts in terms of symptoms and harms.

### **NPS** e-learning resource

A new e-learning resource is available from Project Neptune, on new/novel and club drugs. Which consists of training modules, that are easy to use for front line clinicians and other practitioners.

Text based modules that walk you through the main points, summarise and then offer you a test. There are seven modules:

- 1: An introduction to club drugs and novel psychoactive substances
- 2: Acute harms and management of depressants (club drugs and novel psychoactive substances)
- 3: Acute harms and management of stimulants (club drugs and novel psychoactive substances)
- 4: Acute harms and management of Synthetic Cannabinoid Receptor Agonists and new hallucinogens
- 5: Chronic harms and management of depressants (club drugs and novel psychoactive substances)
- 6: Chronic harms and management of stimulants (club drugs and novel psychoactive substances)
- 7: Chronic harms and management of Synthetic Cannabinoid Receptor Agonists and new hallucinogens

#### **Validity of Prescriptions**

There has been an increase in the dispensing. Schedule 2, 3 and 4 number of incidents reported relating to out-of-date prescriptions date the prescription was signed being dispensed against. Prescription dates should be

supply must be made within 28 days and the remainder of the instalments must be dispensed in the prescription.

#### **County Lines**
